

## **Terms and Conditions – 2021 MS Moonlight Walk – BIG4 Holiday Parks Prize Promotion**

1. Entry into the 2021 MS Moonlight Walk Raise BIG4 Holiday Parks Prize Promotion (“Promotion”) is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence on 9:00hrs AEST 22 March 2021 and close at 23:59hrs AEST 28 March 2021 (“Promotion Period”).
3. Entry is open to MS Moonlight Walk participants (“Entrants”).
5. The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter have reason to believe breached any of these conditions, or engaged in any unlawful or otherwise improper misconduct calculated to jeopardise the fair and proper conduct of the competition. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
6. To enter, Entrants can raise any donation amount during the promotion period and apply funds raised to their individual fundraising page for the MS Moonlight Walk.
7. Each valid entry received during the Promotion Period will be placed in the Major Prize Draw. There is no limit to the number of entries per participant. Each additional donation is an additional entry, and include self-donations.

12. The Prize Winners will be advised within five (5) business days of the draw and their name may be published on the MS Moonlight Walk Facebook page, and email communication.
13. The Prize Winners will be contacted by email or phone with details on how to claim their prize.
14. Entries must be received by the Promoters within the Promotion Period. Entries are deemed to be received upon the verified total of the participants fundraising page increasing by any donation amount during the promotion period.
15. Prize conditions:
  - 15.1. The value of the prize pool is accurate at the date of commencement of the Promotion Period. The Promoter accepts no responsibility for any variation in the value of the Prize after that date.
  - 15.2. This prize is not redeemable for cash.
  - 15.3. The Promoters reserve the right to change any terms contained in these Terms and Conditions of Use at any time without notice
  - 15.4. The Promoter’s decision is final, and no correspondence will be entered into, including in the event of a dispute.
  - 15.5. If for any reason the prize is not claimed, the prize will be forfeited.

15.6. If a Prize Winner is under the age of 18 years (where entry by persons under 18 is permitted), the Promoter will award the prize to the Major Prize Winner's parent or guardian.

17.1. If any act or omission, event or circumstance occurs which is beyond the reasonable control of the Promoter and which prevents the Promoter from complying with these Conditions of Entry, the Promoter will not be liable for any failure to perform or any delay in performing its obligations.

17.2. The Promoter reserves the right, subject to any applicable law, to cancel, terminate, modify or suspend the Promotion.

17.3. The Promoter will not be liable for any loss or damage whatsoever which is suffered, including but not limited to indirect or consequential loss, or for any personal injury suffered or sustained as a result of receiving, taking or using any Prize except for any liability which cannot be excluded by law.
