

Terms and Conditions – 2021 MS Moonlight Walk – Sock Incentive (first 1000) Promotion

1. Entry into the 2021 October MS Moonlight Walk sock incentive (“Promotion”) is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence on 12:00hrs AEST 15 July 2021 and run for the first 1,000 registrants (ticket account holder) to sign up for the 2021 October MS Moonlight Walk (“Promotion Period”).
3. Entry is open to MS Moonlight Walk participants (“Entrants”).
4.  - 12.6. If a Prize Winner is under the age of 18 years (where entry by persons under 18 is permitted), the Promoter will award the prize to the Major Prize Winner’s parent or guardian.
